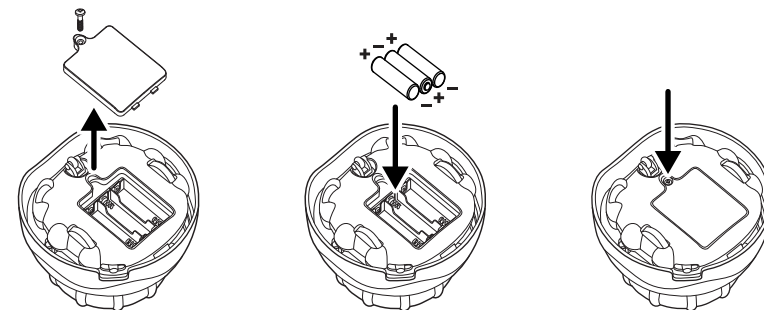
CONTENTS:



Please note: Crab is shipped in the open position. Once the batteries are inserted, the shell will automatically reset to its closed position.

INSERTING THE BATTERIES:

Adult assembly required.



Requires 3 AA batteries.
1. Loosen the battery door screw using a Philips head screwdriver.

2. Open battery door compartment and insert three new AA (1.5V) Alkaline batteries. Be sure to insert with correct polarity.

3. Position the battery door securely back into place and tighten with a screwdriver.
***Batteries should be replaced by an adult.**
***Do not use without battery door properly attached.**

BATTERY INFORMATION: Always dispose of used batteries properly. See section on safety and disposal information. • Batteries are to be inserted with the correct polarity. • Do not burn batteries. • Non-rechargeable batteries are not to be recharged. • Rechargeable batteries are only to be charged under adult supervision. • Rechargeable batteries are to be removed from the toy before being charged. • Exhausted batteries are to be removed from the toy. • The supply terminals are not to be short-circuited. • Different types of batteries or new and used batteries are not to be mixed. • Do not mix alkaline, standard (carbon-zinc), or rechargeable batteries.

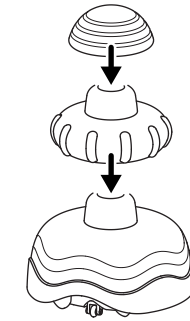

STACKING MODE:



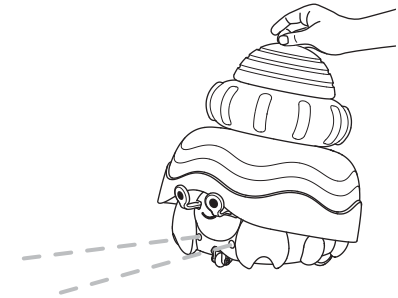
STACKING MODE: Stack Rattle Ring and Soft Teether on to Stacker Base for rewarding lights & sounds.



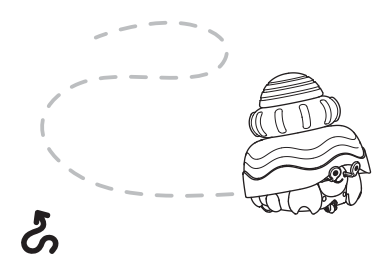
CRAWLING MODES:

TO ACTIVATE CRAWLING MODES: Slide switch to desired crawl mode, then tap the top of the shell or wait for the crab to go. The crab will crawl for the duration of a song then go back into hiding. Tap again to restart the fun.

SENSOR: When crab detects a wall or other solid object, it will make a sound and pivot in a new direction to avoid it.



CIRCLE MODE: For beginner crawlers
Shell will lift up and crab will move in a circular path.



RANDOM MODE: For advanced crawlers
Shell will lift up and crab will move in a random path.

CLEANING AND CARE:

Wipe clean with a slightly damp cloth. Air dry. To prolong the life of this product, remove batteries when toy is in storage. Do not drop on hard surfaces or expose to moisture. Do not submerge in water.

NOTES:

- Sensor is light-sensitive and works best indoors. Not recommended for use in direct sunlight.
- Product works best on a smooth, hard floor or mat. May run more slowly on low-pile carpet. Not recommended for use on high-pile carpet or shag rugs.
- The sensor is designed to avoid all obstacles, but will run best in an area free from too many obstacles, like furniture legs, as it needs space to turn and pivot.
- Always turn switch to the OFF position when not in use.
